- Social Security card or ITIN for each family member
- W-2 forms for all jobs held and all 1099 or 1098 forms
- Child care provider information
- A voided check to direct deposit your refund
- Last year's tax return (if you have it)
- Health insurance statement form 1095-A, 1095-B or 1095-C (if you have it)
